1. CDC Announces New Goals and Organizational Design

Centers for Disease Control and Prevention (CDC) announced on May 14, 2004, new goals and integrated operations that will allow the federal public health agency to have greater impact on the health of people around the world. The announcement evolved from an ongoing strategic development process called the Futures Initiative. The CDC will align its priorities under two overarching health protection goals: 1) Preparedness and 2) Health Promotion and Prevention of Disease, Injury and Disability. The new organization coordinated the agency's existing operational units into four coordinating centers to help the agency leverage its resources. The new coordinating centers and their directors are: Coordinating Center for Infectious Diseases – Dr. Mitchell Cohen; Coordinating Center for Health Promotion – Dr. Donna Stroup; Coordinating Center for Environmental Health, Prevention, and Occupational Health – Dr. Henry Falk; and Coordinating Center for Health Information and Services – Dr. James Marks. Additionally, there will be two major offices: Office of Global Health with Dr. Stephen Blount in the lead and the Office of Terrorism Preparedness and Emergency Response led by Dr. Charles Schable. 2. NASEMSD and NAEMSP Express Concerns to JCAHO Regarding Ambulance Accreditation

Recent industry correspondence indicates that the Joint Commission on Accreditation of Healthcare Organizations (JCAHO) is considering instituting an accreditation program for ambulance operations in the United States. The Commission on Accreditation of Ambulance Services (CAAS) has requested a meeting with JCAHO to engage in a candid discussion of how best to serve medical transportation providers seeking accreditation. NASEMSD and the National Association of EMS Physicians (NAEMSP) on May 12, 2004, sent a letter to JCAHO expressing concern. The letter noted that CAAS has been accrediting ground ambulance providers since 1990. Similarly, the Commission on Accreditation of Medical Transport Systems (CAMTS) accredits approximately 100 medical transport systems in the United States and Canada. "We believe that CAAS and CAMTS serve their respective industries effectively, and we continue to support and actively participate in their accreditation processes," stated the letter. 3. NFPA Standard Recommended to 9-11 Commission

The American National Standards Institute (ANSI) recommended to the 9-11 Commission that a National Fire Protection Association Standard, NFPA 1600 Standard on Disaster/Emergency Management and

Business Continuity Programs, be recognized as the national preparedness standard. NFPA 1600 establishes a common set of criteria for disaster management, emergency management and business continuity programs. In addition, it identifies methodologies for exercising those plans and provides a listing of resource organizations within the fields of disaster recovery, emergency management and business continuity planning. 4. NGA Releases Paper on State Strategies for Accelerating Enhanced 9-1-1 Implementation

The National Governors Association (NGA) has prepared an Issue Brief, "State Strategies for Accelerating Enhanced 9-1-1 Implementation," to provide an overview of several state strategies to be considered to achieve E9-1-1 service delivery goals. According to the report, the deployment of wireless E9-1-1 service is among the most urgent Homeland Security enhancements states currently face. Recognizing the critical need to improve 9-1-1 service, the FCC passed rules in 1996 that required all wireless carriers to provide pinpoint location information to the PSAPs or 9-1-1 dispatch centers by Dec. 31, 2005. 5. NGIA Building a Single Homeland Security Geospatial Infrastructure Database

The National Geospatial-Intelligence Agency (NGIA), in close coordination with the U.S. Geological Survey (USGS), and in partnership with the Department of Homeland Security (DHS), is building a single Homeland Security geospatial infrastructure database. The initiative is contractor supported, and many state EMS directors already may have been contacted. They are gathering location data on fire and police stations, hospitals, or other emergency services sector entities across the country. 6. GAO Compiles Recommendations on Homeland Security

The Government Accounting Office (GAO) released a report that compiles recommendations on homeland security. Hundreds of recommendations have been made through Congressionally Chartered Commissions and GAO investigations. GAO was asked to review the reports of selected commissions and previously issued GAO reports and testimonies in order to identify the strategic recommendations made and organize them both by critical mission area and topic area. 7. Bridgestone/Firestone Tire Recommends Program for Emergency Vehicle Tire Maintenance

Bridgestone/Firestone North American Tire, LLC, is currently conducting a campaign to alert public and private ambulance companies and EMS units throughout the United States to institute a program for tire safety and maintenance. They recommend a program to continually visually inspect all tires on the emergency vehicles for road hazard damage, cuts, and tears, and check the inflation to be sure it is enough for the service the tires experience. Bridgestone is sending a letter, technical bulletins, and a brochure to NASEMSD's EMS provider database list during this campaign. All of the items in the mailing have been endorsed by NHTSA. 9. Epilepsy Foundation Updating Treatment Guidelines

In 1993, the Epilepsy Foundation developed recommended guidelines for the treatment of status epilepticus. The Foundation has recently undertaken the project of updating these guidelines and has appointed a workgroup of professionals with extensive expertise in neurology, epilepsy, and emergency medicine. Throughout the process, the workgroup would like to have constituent organizations review the draft guidelines. NASEMSD would like to designate a point of contact for this project. 10. CDC Releases New Set of Injury Data

The Centers for Disease Control and Prevention (CDC), The Council of State and Territorial Epidemiologist (CSTE), and the State and Territorial Injury Prevention Directors' Association (STAIPDA) have released the second edition of the "State Injury Indicators Report" with 1999 data. Twenty-six state health departments voluntarily participated in this surveillance effort. The second edition incorporates data from a greater number of states and includes data on the poisoning indicator, with both gender and age-specific rates. The indicators were calculated by using state-level data from death certificates and hospital discharge records coupled with data from several national surveillance systems. 11. Dr. Ileana Arias Named Acting Director of CDC Injury Center

Dr. Sue Binder will be retiring from the Centers for Disease Control and Prevention (CDC) on June 7. She has served as the director of the Injury Center since December 2000. The acting director of the Injury Center will be Dr. Ileana Arias. She is a clinical psychologist with research expertise in intimate partner and family violence. She is currently the chief of the Etiology and Surveillance Branch of the Division of Violence Prevention at the Injury Center. She joined the CDC in 2000.

12. Mitretek and Harvard University Sponsor New Innovations in Homeland Security Award

Mitretek Systems and the Ash Institute for Democratic Governance and Innovation at Harvard's JFK School are accepting nominations for the first annual "Mitretek Innovations in Homeland Security Award." This is the first major national award program of its kind created since 9/11, to discover, recognize, and honor, the most effective programs designed to address homeland security. With this award the most effective and innovative programs will gain national attention and be more effectively integrated into urgent national policy and practice.
